Trustee Goett seconded the motion, which was approved by a vote of 6-0. Trustee Reichert moved to Ordinance 2015-1427 regarding liquor in the Village. Trustee Cumming seconded the motion, which was approved by a vote of 6-0. Trustee Cumming moved to approve Ordinance 2015-1428 regarding ordinance violation penalties. Trustee Reichert seconded the motion, which was approved by a vote of 6-0. Trustee Carter moved to approve Ordinance 2015-1429 which creates a registry for interested development parties in TIF District 1. Trustee Goett seconded the motion, which was approved by a vote of 6-0. Trustee Carter moved to approve Ordinance 2015-1430 which creates a registry for interested development parties in TIF District 2. Trustee Harn seconded the motion, which was approved by a vote of 6-0.
