- Fire: Trustee Reichert said things have been quiet.

Dave Marfell explained that a strategic plan is being put in place for the employees to follow relating to snow plowing. He also stated that he made some changes to the water system to help with water quality, which was no health risk to the public. Trustee Harn made a motion to approve an MFT Resolution in the amount of \$24,541.25 for standard maintenance operations. Trustee Goett seconded the motion which was approved 4-0.
