**Executive Session** 

December 6, 2016

Chief Sutton gave an update on the dispatch consolidation project. The Village and Chillicothe are awaiting final approval from the state to consolidate with the dispatch center remaining in the Heights via a waiver. The ETSB board has approved the request locally.
