AN ORDINANCE PERTAINING TO THE ESTABLISHMENT OF PARKING REGULATIONS, SCHEDULES AND FINES WITHIN THE VILLAGE OF PEORIA HEIGHTS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF PEORIA HEIGHTS, ILLINOIS, A MUNICIPAL CORPORATION,

SECTION 1: The President and Board of Trustees, as authorized by State law, hereby declares and determines, upon the basis of traffic investigation needs for ingress and egress, and in the interest of the public health and safety, certain parking, no parking, limited parking and other parking regulations shall be applicable upon specified streets and in certain specified areas within the Village.

SECTION 2: It is hereby determined that, upon the basis of engineering, traffic and police investigation as authorized by law, certain portions and areas along or upon certain streets of the Village should be designated by the President and Board of Trustees as no parking areas. The no parking areas upon those streets or portions thereof are described in Schedule "P" and hereinafter designated as "No Parking", "Loading Zone", or "Restricted Parking locations to be enumerated on said schedule by street location. It is hereby declared in the interest of safety and public health that there shall be restricted parking in the areas of those streets or portions thereof as described in Schedule "P" when appropriate signs are so erected in said areas giving notice thereof. Schedule "P" shall be on file in the office of the Village Clerk.

SECTION 3: It shall be unlawful for any person to park or stop any vehicle along or upon any roadway in the Village in any place designated as a restricted parking area as set forth in Schedule "P" and the operator or person in possession of said vehicle shall be subject to the penalty provisions set forth in this Ordinance.

SECTION 4: ERECTION OF SIGNS: The Village shall furnish, install and maintain proper signs for the enforcement of the provisions of this Ordinance.

SECTION 5: PARKING VIOLATIONS; SETTLEMENT OF CLAIMS: Any person accused of violating the provisions of this Ordinance, as hereinbefore set out, may settle each violation by paying in person or by mail to the Peoria Heights Village Clerk, or their official designee, the amounts for each violation as follows:

- A. Overtime Parking Violations
 Within fourteen (14) days that such violation was committed \$ 5.00
- B. Prohibited Parking Violations
 Within fourteen (14) days that such violation was committed \$15.00
- C. Within fifteen (15) feet of a Fire Hydrant
 Within fourteen (14) days that such violation was committed \$20.00

SECTION 6: RESPONSIBILITY FOR VIOLATION, IMPOUNDMENT OF VEHICLE: It is unlawful for the operator of a vehicle to park such vehicle upon the street in violation of any sign where parking is heretofore or shall hereafter be prohibited during the designated hours or at all time as the case may be. Whenever any vehicle shall have been stopped, standing or parking violation of any provisions of this Ordinance, the operator of the motor vehicle and/or the person in whose name such vehicle is registered shall be subject to the penalty for such violation.

SECTION 7: ADMINISTRATIVE ADJUDICATION: The Village of Peoria Heights has adopted Ordinance No. 1138, "an Ordinance to establish a system for Administrative Adjudication and Violations of Village Ordinances" for the purpose of expeditiously processing Ordinance Violations by Administrative Adjudication. Ordinance No. 1138 provides a form for the same and the process and procedures for hearing violations of

Village Ordinances. That Ordinance No. 1138 is hereby adopted for the purpose of expeditiously processing any citations for any violations of this Ordinance.

SECTION 8: PENALTY: Any violations of this Ordinance shall be punishable by a fine of not less than \$60.00 or more than \$500.00

- (a) Settlement Payments shall be made to the Village of Peoria Heights Police Department, 4901 N. Prospect Road, Peoria Heights, Illinois 61616. Upon the failure of a recipient of a citation or notice of violations of this Ordinance, to timely pay the prehearing settlement amount, recipient shall be required to appear at the Administrative Adjudication hearing at the time and place set forth on the citation or notice of violation. If the recipient shall fail to appear at the time and place, as noticed, a Judgment of Guilty and fine and costs may be entered against the recipient who fails to appear, pursuant to the provision of this Section.
- (b) That upon a finding that a person has been adjudicated, guilty or liable for any charge violation of this Ordinance, by a hearing officer, pursuant to the provisions of Ordinance 1138, an ordinance establishing a system for Administrative Adjudication for Violations of Village Ordinances within the Village of Peoria Heights, the hearing officer may assess, for each violation in addition to any fine, costs not to exceed \$75.00, as set forth in Ordinance 1146 of the Village of Peoria Heights, adopted May 18, 1999.

SECTION 9: All previous Ordinances, including but not limited to Ordinance 996, being an Ordinance "pertaining to the establishment of parking regulations, schedules and fines within the Village of Peoria Heights, Illinois", passed July 17, 1984, are hereby repealed.
